South Atlantic & Caribbean

Lacey Act



NOAA OLE Special Agents from the Marathon, FL field office along with Agents from the USFWS attended the sentencing for Key Marine, Inc., Eric Pedersen, and Serdar Ercan in Key West, Florida in December. U.S. District Judge Jose Martinez sentenced the defendants as a result of their conspiracy to violate the Lacey Act for harvesting, capturing, and selling various species of marine wildlife from the Florida Keys National Marine Sanctuary and state waters. Pedersen was sentenced to 24 months in prison, followed by two years of supervised release, fined \$10,000, barred from dealing in wildlife during



his probation and ordered to forfeit his vessel. Ercan received a sentence of one year and a day in prison, followed by one year of supervised release and a fine of \$6,000. The two men's scheme included illegally harvesting and marketing marine life from the Florida Keys to wholesalers throughout the United States and abroad through their business Key Marine, Inc. According to the charging documents, between October 2010 and February 2011, the defendants illegally collected, exported, and sold in interstate and foreign commerce various species of marine life, including Live Rock and attached invertebrates, coral, sea fans, and several species of sharks. The Information alleges the defendants exceeded the legal limit on the harvest of coral as part of their illicit harvesting activities. The defendants did not possess any permits or licenses to remove or sell marine wildlife.



NOAA OLE Special Agents from the Miami, FL field office and officers from the FWCC completed the investigation of Toby Lamm for violating the Lacey Act. Lamm was sentenced on December 23, 2013, in U.S. District Court by U.S. District Judge Jose Martinez to two years' probation and a \$2,500.00 fine for criminal violations of the Lacey Act. Lamm had previously pled guilty on October 4, 2013, for a case which involves Lamm returning from the Bahamas in possession of 338 queen conchs, 11 wrung lobsters tails, 31 stone crab claws and 200 pounds of snapper fillets all in violation of Bahamian and Florida law.

NOAA OLE Special Agents from the Marathon, FL field office along with Agents from the USFWS, attended the sentencing of Ammon Covino and Christopher Conk on December 2, 2013. The men were sentenced in Key West, FL following being found guilty of criminally conspiring to harvest, transport, and sell spotted eagle rays and lemon sharks, knowing they were taken, possessed, transported, sold, and intended to be sold in violation of the laws and regulations of the state of Florida, contrary to the Lacey Act. Covino was sentenced to one year and a day in prison, followed by a term of supervised release of two years and was also barred from dealing any with marine life during his probation. Conk received a sentence of four months in prison followed by two years of supervised release. As part of Conk's sentence, 180 days of the supervised release is to be served in home detention. Covino and Conk engaged in a conspiracy to purchase and transport wildlife, including spotted eagle rays and lemon sharks from the Florida Keys to Idaho for exhibit at the Idaho Aquarium in Boise, all in violation of the Lacey Act.

NOAA OLE Special Agents from the Marathon, FL field office along with Agents from the USFWS completed an investigation involving a conspiracy to unlawfully transport, sell, receive, acquire, and purchase fish and wildlife. On November 25, 2013 Joseph Franko entered a guilty plea before a U.S. Magistrate Judge in Key West. On December 2, 2013, co-defendant Richard Perrin also entered a guilty plea in the same courtroom. Franko and Perrin admitted conspiring with others to transport, sell, receive and acquire Sea Fans, ornamental tropical fish, sharks and alligators all the while knowing the wildlife was intended to be sold in violation of the laws and regulations of the state of Florida and in violation of the Lacey Act. Sentencing is set for March 25, 2014 in Key West.

A NOAA OLE Special Agent from the Aguadilla, PR field office along with Agents from the FBI completed an investigation involving the illegal sale of sea turtle meat. On November 18, 2013, Manuel Garcia-Figueroa pleaded guilty to a felony violation of the Lacey Act for the illegal sale of sea turtle meat.



Between December 2009 and January 2010, the defendant admitted to selling more than \$350 worth of meat and carapaces from endangered hawksbill sea turtles, and meat from a threatened green sea turtle. In July 2013, the Justice Department's Environment and Natural Resources Division and the U.S. Attorney's Office in Puerto Rico announced the formation of the Puerto Rico Environmental Crimes Task Force to investigate and prosecute environmental crimes on the island. Under the new task force, federal investigative agencies are coordinating their efforts to investigate and prosecute those responsible for committing wildlife and pollution-related crimes. Sentencing is scheduled for February 18, 2014. This case was the result of a joint undercover operation by NOAA OLE and the FBI.



NOAA OLE Special Agents from the Marathon, FL field office along with Agents from the USFWS completed an investigation involving conspiracy, Lacey Act, and wire fraud violations. On November 13, 2013, Dean Trinh was sentenced to serve five months' home detention and ordered to pay a \$10,000 fine to the Lacey Act Reward Fund, along with \$14,400 in restitution. Trinh previously pleaded guilty to criminal conspiracy, Lacey Act and wire fraud violations stemming from the illegal take and sale of California leopard sharks from the San Francisco Bay and nurse sharks from Florida waters. Trinh operated a business in California known as Aquatop USA, LLC,

which, among other things, advertised the sale of nurse sharks on eBay and Craigslist. Between August and October 2009, Trinh admitted to taking undersized California leopard sharks from the San Francisco Bay and selling them through his businesses to customers in Canada and Florida. The defendant also conspired to transport, sell, receive, and purchase illegally collected nurse shark pups over the internet. The California Academy of Sciences was paid \$5,400 of the restitution and \$9,000 is to be paid to the National Fish and Wildlife Foundation. Trinh will forfeit his truck and fishing vessel, and will relinquish all rights to any state fishing, hunting, or other wildlife collecting licenses.



NOAA OLE Special Agents from the Port Orange, FL field office were advised by NOAA GCES that a written warning was issued to two individuals for illegally gigging red drum in Georgia, then transporting the fish to Florida and selling the fish. The investigation was a joint effort between NOAA OLE, FWCC and Georgia DNR.

National Marine Sanctuaries Act

NOAA OLE Special Agents from the Miami, FL field office investigated a case for fishing in a Special

Protected Area (SPA). A \$600 Summary Settlement was issued to Harold Jimenez-Pino and Dariel Montero-Sabido for fishing in the SPA in the Florida Keys National Marine Sanctuary (FKNMS). The Summary Settlement was satisfied.

NOAA OLE Special Agents from the Miami, FL field office investigated a case for spearfishing in a Special Protected Area (SPA). A \$600 Summary Settlement was issued to Luis Garcia-Diego and Yosvany Vega for spearfishing in the SPA in the Florida Keys National Marine Sanctuary (FKNMS).

NOAA OLE Special Agents from the Miami, FL field office investigated a case for discharge deposit of non-exempt materials. An \$800 Summary Settlement was issued to James Padgett for discharging deposits of non-exempt materials in the Florida Keys National Marine Sanctuary (FKNMS).

Magnasun-Stevens Act

NOAA OLE Special Agents from the Miami, FL field office investigated a case for failure to register a fishing tournament. A \$2,000 Summary Settlement was issued to the Anthony Albelo, owner/operator of the fishing tournament "Sailfish Kickoff." The owner/operator had previously been advised of the requirement to register the tournament and failed to do so.

NOAA OLE Special Agents from the Port Orange, FL field office was advised by NOAA GCES that a \$300 Summary Settlement for possession of red snapper was paid by Paul Copperthwaite, the owner/operator of a St. Augustine, FL recreational vessel; the case was initiated by FWCC officers on patrol in federal waters.

A NOAA OLE Special Agent from the Port Orange, FL field office conducted a patrol with FWCC in St. Augustine, FL and a dockside inspection of a commercial snapper-grouper F/V RUBBER DUCK revealed 237 lbs of red snapper which was over 3 times the legal limit of 75 lbs. The excess red snapper was seized and sold for \$1,185.

A NOAA OLE Special Agent from the Port Orange, FL field office conducted personal service of a \$1,800 NOVA issued by NOAA GCES to an individual in Jacksonville, FL who was charged with the possession of 23 undersized black sea bass harvested from federal waters. The case was initiated by FWCC officers patrolling offshore of Mayport, FL.

Endangered Species Act



NOAA OLE Special Agents from the Miami, FL field office and the FWCC completed an investigation involving violations of the Endangered Species Act. On December 23, 2013, Robert Jaques pled guilty and was sentenced for violations of the Endangered Species Act, in U.S. District Court in West Palm Beach, FL. U.S. Magistrate Judge William Matthewman sentenced Jaques to a term of imprisonment for 10 days. The case involved Jaques offering the sale of endangered sawfish rostrums via the internet. This case was the result of a joint undercover operation by the NOAA OLE and the FWCC.

A NOAA OLE Special Agent from the Charleston, SC field office was advised by NOAA GCES that the owners/operators of the Antigua-flagged M/V MARE LYCIUM agreed to pay \$124,200 to settle a NOVA for violating speed restrictions, enacted to protect critically endangered North Atlantic right whales. The investigation documented more than 485 miles of



egregious violations in SMAs off of New York, New Jersey, South Carolina and Florida.

A NOAA OLE Special Agent from the Port Orange, FL field office participated in multiple joint TED patrols with the FWCC in the waters off of northeastern Florida. Ten shrimping vessels were boarded resulting in one fix-it ticket for a minor infraction found during the inspection.

A NOAA OLE Special Agent from the Charleston, SC field office issued a \$100 summary settlement to Edwin Magwood, captain of the commercial F/V WINDS OF FORTUNE after USCG personnel documented that the trawler, which was fishing offshore of South Carolina, had an escape flap measuring seven inches beyond the maximum allowable length.

COPPS & Outreach

A NOAA OLE Special Agent from the Marathon, FL field office is assisting the Sugarloaf Elementary School Marine Science Program, which includes grades 6-8, as a mentor. The Agent participated in a site visit within the Florida Keys National Marine Sanctuary and explained the rules and regulations within the sanctuary.

A NOAA OLE Special Agent from the Port Orange, FL field office participated in the 2013 Right Whale Festival in Jacksonville Beach, FL where the Agent answered questions about NOAA OLE and regulations enacted to protect critically endangered North Atlantic right whales.

Partnerships

A NOAA OLE Special Agent from the Port Orange, FL field office was on vessel patrol when he observed a wooden raft with three juveniles on it, which was in the

Intracoastal Waterway. After contacting FWCC, the agent towed them to a local public dock due to increased vessel traffic and strong currents controlling the raft. The juveniles were turned over to an adult relative safely who secured the raft to the dock.



NOAA OLE Special Agents from the Marathon, FL field office gave a presentation on the Office of Law Enforcement organization and operations at the USCG Station Marathon. The Agents explained OLE roles, duties, and shared intelligence and past successes.

NOAA Special Agents from the Miami, FL field office gave a presentation to the Pelagic Observer Program (POP) during the observers refresher training held at the SEFSC in Miami.

A NOAA OLE Special Agent from the Port Orange, FL field office provided an Oculina Bank enforcement update presentation to the South Atlantic Fishery Management Council snapper-grouper committee in Wilmington, N.C.

A NOAA OLE Special Agent from the Charleston, SC field office worked with personnel at the Charleston International Airport to inspect records and discuss federal statutory requirements regarding the interstate

and international shipping of seafood and marine products.

A NOAA OLE Special Agent from the Port Orange, FL field office participated in a right whales coordination meeting with USCG Sector Jacksonville and NMFS Protected Resources; the Agent provided an update on speed restriction and close-approach enforcement efforts.

A NOAA OLE Special Agent from the Charleston, SC field office traveled to Savannah, Georgia and represented the OLE SE Division on the Gray's Reef Sanctuary Advisory Council by briefing the Acting SAC on OLE investigations and providing input for enforcement issues.

A NOAA OLE Special Agent from the Miami Field Office was interviewed by the NOAA Coral Reef Conservation Program regarding the implementation of capacity assessments in U.S. coral reef states and territories.

Training

NOAA OLE Special Agents assigned to the Southeast Division, District II, completed quarterly firearms training and qualifications in Loxahatchee, FL at the Palm Beach County Sheriff's Office Training Facility.

A NOAA OLE Special Agent from the Miami, FL field office successfully completed the NOAA Small Boat Program PQS during a check ride conducted onboard NOAA RHIB F2416 in New Smyrna Beach, FL.

A NOAA OLE Special Agent from the Miami, FL field office attended the Intellectual Property/Product Substitution training put on by the National White Collar Crime Center (NW3C).

A NOAA OLE Special Agent from Port Orange, FL and an Enforcement Officer from Niceville, FL provided the "Proper Enforcement of Turtle Excluder Devices" training program to field officers and the combined crews of multiple FWCC patrol vessels.

A NOAA OLE Special Agent from the Charleston, SC field office provided training to approximately 25 USCG boarding officers on NOAA OLE investigation techniques to multiple classes at the Southeast Regional Fishery Training Center in Charleston, SC.

A NOAA OLE Special Agent from the Port Orange, FL field office worked with NMFS International Affairs and NOAA GC to discuss future IUU training and specific training developed by the agent for the Liberian Bureau of National Fisheries.

Gulf of Mexico

Magnuson-Stevens Act

A NOAA OLE Special Agent from the St. Petersburg, FL SED office testified before a federal Grand Jury in Mobile, AL leading to the criminal Indictments of Matthias Kumm, Natalie McArdle, James Martin, David Braley, Tiffany Wilson, John Whitworth, Josh Jones and Hunter Evans for alleged violations of the Lacey Act and/or false statements. The charges are the result of a longterm undercover investigation conducted by the NOAA Niceville field office, FWCC and ADNR and stem from allegations related to the illegal harvest, sale and/or false reporting of Gulf of Mexico IFQ species of red snapper and grouper landed in the Florida panhandle and Baldwin County, AL.



A NOAA OLE Special Agent and an ASAC from Niceville, FL field office attended the Change of Hearing plea for Thomas Zachary Breeding. Breeding had been indicted on a three count criminal Indictment for one count of altering his GPS onboard the F/V WOLF in an attempt to conceal fishing inside The Edges Closed Area and two counts of making false statements to NOAA OLE agents on two occasions. Breeding changed

his plea to Guilty of all three counts and was subsequently sentenced to 15 months incarceration by US Federal Judge Richard Smoak in Panama City; FL. Breeding also received two years probation, a \$300 fine and must appear before Judge Smoak for approval before he can engage in any commercial fishing activity in the future. Breeding was initially detected inside the closed area by a SED VMS technician who alerted the NOAA OLE agent. Breeding who was warned the previous week for similar activity, also had \$26,000 in outstanding fines from previous documented closed area violations which were brought up during his sentencing hearing.

NOAA OLE Special Agents from the Slidell, LA field office investigated the owner and captain of the F/V LADY LYANNA for the illegal finning of sharks and landing over-the-limit of sharks. When the vessel was boarded, a total of 2,076 shark fins were found hidden in a secret compartment and had been illegally removed from the sharks prior to landing. On November 25, 2013, NOAA GCES issued the owner and captain each a \$45,000 NOVA.

NOAA OLE Special Agents from the Slidell, LA field office investigated the owner and captain of the F/V LUCKY STAR I for illegally fishing in the Gulf of Mexico with an expired GOM Federal Shrimp Permit. The vessel was given a Written Warning by NOAA GCES on October 22, 2013.

NOAA OLE Special Agents from the Slidell, LA field office investigated the owner and captain of the F/V MY DAD WHITNEY for the illegal possession of closed season red snapper, over-the-limit red snapper and the possession of fillets. NOAA GCES issued a \$2,500 NOVA and reached a Settlement Agreement in the amount of \$2,070 on January 8, 2014.

A NOAA OLE Enforcement Officer from the Slidell, LA field office issued a \$300 Summary Settlement to Joseph Pierre for possession of two red snapper during

the closed season. The Summary Settlement was paid in full.

A NOAA OLE Enforcement Officer from the Slidell, LA field office issued Summary Settlements totaling \$625 to multiple crewmembers of the F/V OCEAN ONE for possession of red snapper during the closed season. The Summary Settlement was paid in full.

A NOAA OLE Enforcement Officer from the Niceville, FL field office issued a \$1,500 Summary Settlement to the F/V JUSTIN TIME for knowingly operating with expired GOM Charter reef fish and Highly Migratory Pelagic permits. The Destin, FL based charter boat was boarded in the EEZ, had paying costumers onboard and was in possession of both Vermilion snapper and King mackerel.

A NOAA OLE Special Agent from the St. Petersburg, FL SED office received notification from GCES HQ that a \$16,000 NOVA was issued to the owner and operator of the F/V BIG DOG for violations of the MSFCMA. While actively fishing, the F/V BIG DOG was boarded and found to be in possession of approximately 293 gangions baited with federally regulated species including red grouper, shark and red snapper. Additionally, while FWCC Officers were onboard, a crewmember dumped a bucket containing 15 red grouper overboard. The captain admitted to the Agent that he directed his crew to “supplement” their onboard bait with the undersized federally regulated reef fish and shark while the crewman admitted to dumping red grouper overboard.

A NOAA OLE Special Agent from the St. Petersburg, FL SED office received notification from GCES HQ that a NOVA in the amount of \$14,000 was issued to the owner and operator of the F/V CAN DO. The vessel landed and offloaded IFQ species without the required allocation; possessed approximately 89 shark fins without the carcasses, and possessed prohibited species.



A NOAA OLE Enforcement Officer from the Niceville, FL field office and FWCC officers conducted sea patrols and subsequently issued four Summary Settlements to recreational anglers Joseph Dagostino for \$375, James Marcengill for \$500, Mark Williams for \$425 and Danny Boklage for \$425, for violation of closed season red snapper and gray triggerfish bag limits. During one patrol the Enforcement Officer assisted the FWCC with a missing person search and rescue in the Santa Rosa Sound. The missing man's body was recovered the following day and an investigation was conducted by the state.

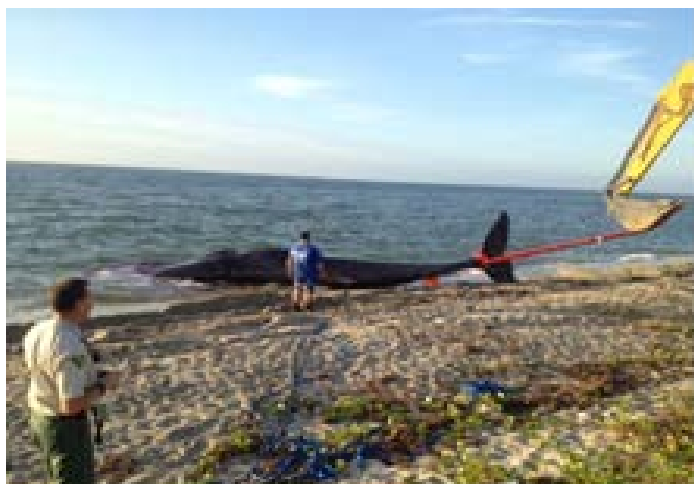
A NOAA OLE Special Agent from the St. Petersburg, FL SED office responded to a complaint alleging that a local fishing tournament organization was illegally selling tournament harvested king mackerel to wholesale fish dealers. After consulting with NOAA Sustainable Fisheries and the FWCC it was determined that state and federal regulations did not prevent tournament organizations from donating fish to wholesale dealers who agreed to forward proceeds to the tournament's charity of choice.

A NOAA OLE Special Agent from St. Petersburg, FL SED office received notice that at the request of a GCES Attorney two Written Warnings were personally served on Tracy Parramore and Donald Causey. The two men were cited by the Florida FWC for possession of red grouper in excess of the bag limit.

Endangered Species Act

A NOAA OLE Enforcement Officer from the Slidell, LA field office received notification that a \$4,275 NOVA was issued to the F/V LADY KIM T for multiple TED violations.

A NOAA OLE Special Agent from St. Petersburg, FL SED office responded to a request from NOAA PRD, involving a beached sperm whale incident in Madeira Beach, FL. The Agent assisted with perimeter control and overnight security after the whale was euthanized and relocated to a nearby county park.



Marine Mammal Protection Act

A NOAA OLE Special Agent from the Slidell, LA field office attended the initial appearance of Brent Buchanan in the U.S. District Court for the Sothern District of Mississippi. During the appearance, Buchanan entered a guilty plea for shooting a dolphin

with a shotgun from the F/V SEAWEED 2000 in the Mississippi Sound. Chief Magistrate Judge Roper released Buchanan on a \$25,000.00 bond and scheduled a sentencing hearing on February 24, 2014. Buchanan faces a maximum fine of \$100,000 and up to one year in prison.

COPPS & Outreach

A NOAA OLE Special Agent from the St. Petersburg, FL SED office participated in a conference call with members of the U.S. Agency for International Development (USAID), NOAA, DOI, and several foreign fishery management ministries this week to discuss program plans for FY14. In particular the group focused on the upcoming RPOA-IUU meeting that is being held in Kota Kinabalu, Malaysia this November which will explore the best resources and methods for addressing IUU issues in the region. Additionally, increasing efforts by the Joint Target Development Teams (JTDT) formed during January's workshop in Cebu, Philippines was a key focus of the call. The JTDTs will concentrate on transboundary IUU fishing threats in region; specifically, Live Reef Food Fish Trade (LRFFT), turtle trade/smuggling and incursions by foreign fishing vessels (FFV). The Agent later travelled to Malaysia where she spent two days in initial meetings involving NOAA, DOI and USAID prior to the RPOA-IUU meetings.

A NOAA OLE Special Agent from the St. Petersburg, FL SED office conducted site visits to several IFQ dealers and landing locations this week from Ft. Myers to Tarpon Springs, FL. At the Agent's request, Blue Star Seafood, Pelican Point Seafood, and AP Bell Seafood provided copies of trip tickets and landing records for multiple vessels in order to resolve discrepancies between landing notifications and dealer transactions. The information will also be provided to SF staff for use during IFQ audits.

A NOAA OLE Special Agent from the St. Petersburg, FL SED field office met with Sustainable Fisheries personnel in response to inquiries from a commercial reef fish permit holder who reported receiving conflicting regulatory information. The permit holder

was provided information clarifying the possession/transiting requirements specific to the demarcation boundaries for the Gulf of Mexico and South Atlantic Fishery Management Councils.

SED NOAA OLE Special Agents and Enforcement Officers participated in a webinar on the Headboat Collaborative Program, a pilot catch share program, for managing Headboat harvest of red snapper and gag grouper throughout the Gulf of Mexico. Through an exempted fishing permit (EFP), participants will be able to harvest red snapper and gag grouper during seasons when such harvest would normally be prohibited. Information on the program, including exemptions and limitations of the EFP, can be found on the SERO Catch Share Program website. The program began on January 1, 2014.

Training

A NOAA OLE Special Agent from the St. Petersburg, FL SED office provided IFQ training to approximately 25-30 Florida FWCC officers and investigators in Tampa. The training was requested by the state to bring new officers up to speed on the Gulf of Mexico IFQ program and to serve as a refresher for officers already familiar with the program. Several Gulf States have been given additional funding from NOAA to conduct dockside patrols targeting vessels and dealers for inspection, thereby increasing visible enforcement of the IFQ program. The training highlighted changes that have been made to particular species managed under the program as well as potential administrative rule changes that are being considered by the Gulf Council.

A NOAA OLE Special Agent from the St. Petersburg, FL SED office continued to work on developing Port State Measures training curriculum that will be utilized for training enforcement personnel in Indonesia. Subject matter includes general conservation measures, international and national laws on IUU fishing, roles, function and ethics of an inspector, foreign vessel document verification and validation and physical examination of foreign vessels.



A NOAA OLE Special Agent from the St. Petersburg, FL SED office participated in a conference call with a NOAA International Program Analyst to initiate the planning and coordination of a trans-boundary operational workshop that will serve as a continuation to the IUU meeting held in Cebu, Philippines earlier this year. This subsequent workshop will bring together law enforcement from Indonesia, Philippines and Malaysia to develop joint operations, investigations and activities to address the IUU target areas identified in Cebu.

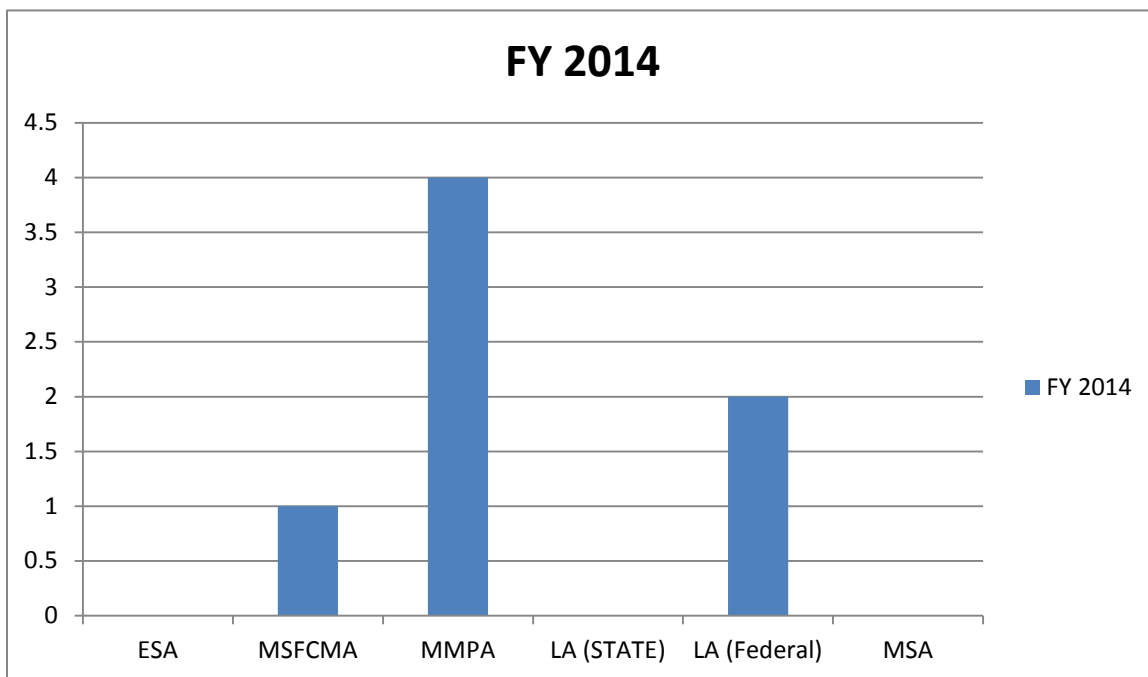
